Involved in service throughout. Mainly at group level, although I regularly submit and have accepted questions at General Service Conference. I have also contributed a number of articles to Share magazine.

I was vice chair of North West London IG in 1979. Secretary of East Midlands IG in 1990-1. and I am currently WTF person for Fenland.

My home group for the past twenty years has been Friday Cheddars Lane meeting in Cambridge.

Basis on which Lea N would like to stand as Intergroup (IG) Chairperson:

- 1. I am committed to the idea of real life Intergroup meetings. I do not believe it is a good idea to make IG virtual on an ongoing basis. (member safety and regulations permitting, of course).
- 2. I am also committed to the idea of IG meetings being held at different locations throughout the Fenland area. I would like to see the next IG after this one organised in Cambridge.
- 3. I would like to work towards seeing more Cambridge representation in the meetings.
- 4. I would like to streamline the way IG meetings are run. The intention would be to reduce meeting length to between an hour and 90 minutes. To achieve this I would like us to consider some of the following:
- a. We end the practise of groups providing verbal reports in the meeting. Group reports would be in written form. Issues arising from groups that "affect other groups or AA as a whole" should be added as agenda items in their own right.
- b. Officer's reports would be provided in written form, and they would only report verbally if they specifically ask to do so, or they specifically require input from the meeting. Any officer could and would take questions if necessary.
- 5. On a broader/wider front It has become apparent during the pandemic that there are a number of issues relating to WTF at both local and national level. In particular the way the GSO website

inter-relates with the local. It is my intention (whether as an IG officer or as an individual member) to focus some attention on these issues.

- ECLO-Page 36. Andy L offered to take over as ECLO, although he does not have 3 years sobriety. He taught himself to programme 40 years ago at 11 years old and has spent his whole working career with computers. He worked in Investment Banking for 30 years running a multi-million-pound computer system. Robin suggested we get Sam to sponsor Andy into the position and a firm decision would be made at the next Intergroup meeting.
