Officers Reports

Chair's Report:

My last report today Intergroup was made in May. We are now another four months into this pandemic. Looking at what has happened in Alcoholics Anonymous worldwide over this period, shows a great ingenuity and adaptability to the situation by people who understand the need to keep in touch. It would have been far nicer to be writing this Report knowing that it could be addressed to you all at a 'face to face' Intergroup meeting, but sadly that will not be the case.

However, there are some bright spots on the horizon. Physical Meetings are springing back to life, all be it with a somewhat reduced access. In keeping with what Alcoholics Anonymous stands for, those opening up rooms have ensured that all the Government Guidelines (and more) are met. Confrontation and non-compliance because we feel we are a special case is not the AA way. At one local meeting in St Neots (Primary Purpose Wednesday night), number are reduced to 21 so that the full 2m rule can be observed. Priority is given at the meeting to the Newcomer, with older members willing to offer their seat to those who need it more. On Saturday 1st August I attended a Workshop run by London North. There were well over 400 of us online and we heard of the efforts of many across the UK who have started physical meeting and, in some cases, combining them with online Zoom meetings. It was a wonderful experience, so many people (Alcoholics) listening and waiting their turn to ask questions or comment. I personally took from that Workshop many ideas which I can now put to other groups in my area and get us back to where we can do most good – in the rooms of a physical meeting.

Being involved as a Responder on the Helpline has brought home to me the effect of this pandemic on the lives of those suffering the pain and anguish of untreated alcoholism. It is truly heart-breaking to talk to them and not be able to offer them a 'Meeting.' As so many of us know that first physical meeting can be the lifeline that gets them on to the road of recovery and lets them know they are 'Not Alone.' Our Intergroup and Region TLO's are doing and have been doing sterling work over the whole of this period and are still doing the same, at times facing their own problems but selflessly still thinking of others.

At this point in time I can see the 'chink of light' in the tunnel ahead and pray to my Higher Power (God) that it is not extinguished. I believe I can say that the majority of Alcoholic's in recovery will not do anything to interrupt the progress that is being made and set back the sacrifices that have

been made. While I am Chair of this Intergroup, I will do all I can to ensure that the Fenland area has the 'Hand of Alcoholics Anonymous' to reach out for when needed.

I have had the opportunity to forward information to other Intergroup PLOs about GSO and prison sponsorship.

As schools are closed the Charity "Prison Me No Way" has suspended all events until further notice

Phyllis H re: Littlehey Prison

I see you are on the cusp of rotation but didn't find anew PLO so I'm coming to you for some advice so that we are ready to go back into Littlehey as soon as maybe.

As we came into Lockdown I was the link into Littlehey having been doing the rota, having met various staff members and currently reporting to Governor Anita Bell, and one of the others on our rota was preparing the calendar.

We had 7 people on the rota. Last autumn the prison said that we all needed to redo our Clearances. There was no deadline set and I personally think that this request was perhaps made coincidentally with our asking if 2 or 3 people could go in on a Visitor pass. The 2/3 new people subsequently dropped back and as far as I know only 3 of our 7 have completed the new Clearance procedure.

Personally, I don't think Littlehey will invite us back because, sadly, they do not seem to rank AA highly, if at all, in their prisoner rehabilitation program. We outsiders were in effect a thorn in their side. No longer was there a Prison AA meeting to which we were guests, but alas if for any reason we visitors did not get in then there was no meeting. Despite various face to face promises to put up posters about the Sunday meeting little evidence was seen by inmates and it was felt by us, and inmates attending, that the prison considered their Drug and Alcohol Rehabilitation totally sufficient. Thought my 7 years of visiting there were usually one or two existing AA members for whom our meetings were a lifeline and we certainly saw "converts". One old -timer made the comment "For one hour a week I am not in prison".

Conventions - Fenland Convention 2020

Fenland Intergroup - 2020 St Neots (online) Convention

The committee had made plans to hold the 3rd consecutive St Neots convention at the Eaton Socon Community Centre. We had already started preparations including taking delivery of printed flyers. With the arrival of coronavirus, those plans had to be cancelled and the committee moved to schedule an online convention, to carry the same message of recovery and provide a day of fellowship and fun!

Room 1 (speakers /main shares):

- Sobriety ranging from 24 hours to 51 years
- 9 shares from UK, USA and Trinidad, including Al-Anon and Alateen
- Attendees from UK, USA, Ireland and Trinidad
- 153 distinct logins across the day, peaked at 79 attendees at one time
- Dedicated paid-for Zoom room for the day, with additional attendee capacity and features
- Service team of 11 dedicated technical hosts to monitor attendees and ensure the room remained a safe place to share

Room 2 (meditation sessions):

- 24 attendees across 2 sessions.
- Sessions run by Nancy, with 2 dedicated technical hosts

Financial Summary:

- Through Tradition 7 and gratitude collections, we raised enough money to cover our costs and also repay the Intergroup £ 1,000 loan.
- In addition, we raised a further £306.58 to pass to Intergroup.
- Detailed financial statement overleaf.

Other notes:

- 47% people joined by computer, 41% by phone, 13% by tablet or unknown device type
- 5 attendees dialed into audio-only via a landline
- 86% people came into the meeting with their camera on
